**WHAT:** CONSTRUCTION REQUIRES CLOSURE OF THE WESTBOUND (WB) STATE ROUTE (SR) 168 CONNECTOR RAMP TO NORTHBOUND (NB) SR 41 AND WB SR 180 TO NORTHBOUND (NB) SR 41, CHESTNUT AVENUE ON RAMP AND CEDAR AVENUE ON RAMP TO WB SR 180, AND ONE EASTBOUND (EB) 180 LANES BETWEEN SR 168 AND SR 41.
